SELECTION CRITERIA

Participation in Leadership St. Mary is open to persons with residence or employment in St. Mary Parish. Classes typically will consist of approximately 20 individuals. Because the number of appointments is limited, applicants who are not selected are encouraged to reapply in subsequent years.

Participants in Leadership St. Mary will be chosen by the Leadership St. Mary Selection Committee based upon the information provided in this application. The Committee will be seeking representation from a demographic cross-section of the Parish. Participants will be community leaders and potential community leaders active in business, education, the arts, religion, government, law, media, labor, community-based organizations, and ethnic and/or minority groups, and will reflect the diversity of the Parish.

Applicants must have the full support of the organization or corporation they represent.
